#### Increasing VIP programmes' responsiveness to Māori: A whānau-centred approach for the VIP programme. Wellington, New Zealand: Ministry of Health.

Summary: This resource was born out of a desire by Violence Intervention Programme (VIP) coordinators working in hospitals across New Zealand to increase the effectiveness of the programme for Māori. Independent evaluation results show that VIP indicators for cultural responsiveness have been increasing over time but more slowly and more variably than others. *Summary*: This qualitative project was the first to study values and practices about sexual assault among migrant communities from the Cook Islands, Fiji, Niue, Samoa, Tokelau, Tonga, and Tuvalu in New Zealand. It aimed to identify customs, beliefs, and practices among these ethnic groups that were protective and preventive factors against sexual violence... <u>Read more</u>

Social Policy Evaluation and Research Unit. (2015). **Family resilience** (In Focus, August 2015). Wellington, New Zealand: Superu.

Summary: Many families cope successfully with difficult situations and can adapt according to their circumstances. What is it about these families that enables them to cope, and even thrive, despite the odds? This paper looks at the capacity of families to respond and adapt as situations arise. Rather than focusing on particular risks or adversities that some families face, or the outcomes that these risks may lead to, it combines resilience and family-level approaches to deepen our understanding of family resilience... <u>Read more</u>

Summary: In 2011 the Kidpower Teenpower Fullpower Trust (NZ) received funding from the Ministry of Justice to create a violence and abuse prevention programme for adults with learning disabilities. Fullpower (NZ) developed a programme called Healthy Relationships building on the curriculum of and in close collaboration with Kidpower Teenpower Fullpower International... <u>Read more</u>
