### **Evidence-based reports**

The purpose of these reports, prepared for ACC, is to provide an evidence-based guide on the association between childhood sexual abuse and various mental health issues as a teenager/adult. These findings will be used to assist in the decision making process regarding cover and entitlements of those who have experienced childhood sexual abuse and later develop a mental health issue. These reviews were all conducted by Ian Lambie, assisted by literature searchers, in 2016, except *Childhood adversity and psychotic disorders*, which was conducted by Mark Ayson in 2014.
