# Are immigrant women visible in Australian domestic violence reports that potentially influence policy?

Summary: Through an intersectional lens, this article explores whether immigrant women are represented in a sample of Australian government documents aimed at providing information about family violence in Australia, and discusses implications for policy development. The authors find that while these documents pay lip service to the special vulnerabilities of immigrant and refugee women; arguably, they do not engage with the complexities of the intersection of gender and other social categories... ### The domestic violence protection order system as entry to the criminal justice system for Aboriginal and Torres Strait Islander people

Summary: The domestic violence protection order (DVO) system is a hybrid system of criminalisation in which the DVO itself is a civil order, but any contravention of that order may result in a criminal charge. Limited attention has been paid to the potential consequences of criminalisation through the hybrid DVO system in the Australian context... Read more

# Exposure to interpersonal violence during pregnancy and Its association with women's prenatal care utilization: A meta-analytic review

Summary: Inadequate prenatal care utilization has been proposed as a mechanism between exposure to violence during pregnancy and adverse maternal and fetal obstetric outcomes. Adequate prenatal care is important for identifying and treating obstetric complications as they arise and connecting pregnant women to supports and interventions as needed. There is some evidence that pregnant women experiencing relational violence may delay or never enter prenatal care, though this association has not been systematically or quantitatively synthesized. The present meta-analysis investigates the relationship between interpersonal violence during pregnancy and inadequate prenatal care utilization across two dimensions: (1) no prenatal care during gestation; and (2) delayed entry into prenatal care... Read more

### #HowlWillChange: Engaging men and boys in the #MeToo movement

*Summary*: In response to the #MeToo movement, #HowlWillChange was intended to engage men and boys in the ongoing discussion about sexual violence by asking them to evaluate their role in sustaining rape culture. The authors collected publicly available tweets containing #HowlWillChange from Twitter's application programming interface on October 26, 2017 via NCapture software, resulting in 3,182 tweets for analysis. Tweets were analyzed qualitatively and coded into three primary groups: (a) users committing to actively engage in dismantling rape culture, (b) users indignantly resistant to social change, and (c) users promoting hostile resistance to social change... Read more

### Long-term housing and intimate partner violence: journeys to healing
