Breaking the web of silence: An exploration of Chinese women's experience of domestic violence in New Zealand

Summary: Domestic violence is a serious social issue within New Zealand society. Asian immigrant women with domestic violence experiences often face specific socio-cultural challenges and barriers that hinder them from making sense of their experience, seeking help and accessing necessary intervention. In New Zealand, there is limited domestic violence research which focuses on the lived experience of women in Asian immigrant communities.

Traumatic brain injuries in New Zealand: National insurance (Accident Compensation Corporation) claims 2012 to 2016

Summary: There were 97,955 TBI injury claims lodged over the duration of the study. The incidence of total TBI in New Zealand was 432 per 100,000 population, and 155 per 100,000 for moderate or severe claims (MSC) TBI claims. This paper does not identify TBI resulting from family violence but notes that further research is warranted into the assessment and management of intimate partner violence and child abuse victims for TBIs... Acquired brain injury in the context of family violence: A systematic scoping review of incidence, prevalence, and contributing factors
