This month's pānui includes new research about the prevalence of different types of intimate partner violence (IPV) in Aotearoa New Zealand. Undertaken by researchers at the University of Auckland, this is the first research to track changes in rates of abuse by New Zealand women's partners over time using population surveys specifically designed to measure violence experience.

This pānui also includes information about current legislation open for submissions including the Harmful Digital Communications (Unauthorised Posting of Intimate Visual Recording) Amendment Bill.
