Kia ora!

September saw communities across Aotearoa celebrate Te Wiki o Te Reo Māori. This year marks 50 years since the Māori Language Petition was presented to parliament on 14 September 1972. The 14th September became Māori Language Day and later Māori Language Week. This year also marks 35 years since te reo Māori became an official language and the launch of the Māori Language Commission in 1987 through the Māori Language Act. In recognition of Te Wiki o Te Reo Māori, we highlight the journey of te reo Māori revitalisation, resources and research about connecting to te reo Māori.

This month we are also highlighting the Harmonised Healthy Relationship Project, which was initiated as part of a response to tamariki Māori requesting better accessible information about intimate partner relationship well-being. As a result of the project, a number of resources have been developed for tamariki/rangatahi in intimate partner relationships or those thinking about what they would like in a healthy intimate partner relationship.
